



OFFICIAL RULES

No carry-ins allowed. Under no circumstances will rough play and/or abusive language be tolerated. Players displaying this type of behavior will be assessed a technical foul and/or dismissed from the game and/or tournament. A referee will be present on all courts. Excessive parent/family intervention will result in disqualification of the team. No yelling at or touching the referee, court marshals/monitors or other officials. It is required that the winning team of each game supply a score keeper for the following game on the same court. He/She will sign a score sheet upon completion of the game affirming the winning team. Failure to do the above will result in the uncooperative team's next opponent being awarded 5 points.

A team may play one, two, or three players at a time. A player can participate on only one team during the entire tournament.

Hoopla 2011 is a double elimination tournament. Teams will play at least 3 games unless receiving a bye.

Hoopla 2011 reserves the right to limit the total number of teams and the number in each division.

Games will be played to 15 baskets of one point each. A team must win by two points. A two point shot line is in effect. There is a 30-minute time limit on each game. Teams will be grouped in divisions by gender, grade, age and other information provided. The designated captain will be held accountable for any falsified information on the entry form. If found prior to the event, the captain will not play. If discovered at any point during the tournament, the entire team will be disqualified (every player must be registered).



RELEASE AND WAIVER OF ALL CLAIMS AGREEMENT REGARDING RISK OF INJURY AND RELEASE

I hereby apply to participate in the Zephyr Hoopla 2011 basketball tournament in Neenah, WI on August 6, 2011. I understand that participating in the tournament will expose me to above normal risks of injury or harm. These risks include, but are not limited to, physical contact or collisions with other players, volunteers, spectators, or inanimate objects on or in the area of the courts; contact with balls or players from other courts; uneven or hazardous playing surfaces or conditions; defective equipment; and other risks or hazards. I represent that I have no health or physical problems that will interfere with my participation in the tournament, and that I will not participate if I develop such problems. I agree that I am responsible for my own safety, and I assume all risk associated with my attendance and participation in the tournament. I agree to fully and forever release, discharge, and agree not to sue Zephyr Hoopla 2011, St. Mary Central High School, Catholic Diocese of Green Bay, Town of Menasha and any and all sponsors or affiliated members (hereinafter referred to as "tournament sponsors") and their officers, directors, agents, employees, representatives, volunteers, and successors, for any and all claims, causes of action or liability for any injury, loss or damage sustained or incurred by me arising out of or any way associated with my attendance at or participation in the tournament, including all claims, causes of action, or other liability of any type of the tournament sponsors hereby released. I understand that both volunteers and paid employees shall participate in all aspects of this tournament, including the providing of first aid and medical care (I understand that first aid or medical care may be provided by doctors, nurses, paramedics, or unskilled volunteers), and this release and waiver shall extend to all claims of negligence or malpractice or liability of any type against such people.

I agree to indemnify and hold harmless tournament sponsors, their agents, or representatives from any loss, damage, or expense sustained or incurred by them arising from any such claims, causes of action, or liability, whether brought to me, anyone acting on behalf of, or by anyone else because of conduct attributed to me.

I also understand that tournament sponsors shall not be held responsible and do not assume responsibility for lost or stolen articles by any participant, team, or other party.

If the participant is a minor, the signature of a parent/guardian on the registration form releases claims of the minor, parents/guardians, and all others with derivative claims.

I have read the above items of the release and waiver, understand them, agree to abide by them, and hereby acknowledge that I have read and understand this release and waiver.
